

Terms and Conditions of the Referral Program

This Offer is personal and is available solely in the country in which you had subscribed to your Deezer's account, from April 1, 2026 to June 30, 2026 (the "Term") and on the Deezer application. The Offer only concerns paying subscriptions to Deezer services (excluding subscriptions (i) via a third-party partner; (ii) via iOS and Android; or (iii) special offers (e.g. student or promotional offers)) whether annual or monthly, available on <https://www.deezer.com/> or on the Deezer application, hereinafter the "Deezer Service(s)".

The conditions and benefits of the offer are as follows (the "Offer"):

- (1) 3 months of subscription to its current Deezer Services offered to the Referrer who has an active subscription to a Deezer Service which will be deducted from their next subscription payment(s)** (subject to the conditions below).

Who can be Referrer: The Referrer is a person who has a subscription to Deezer Services (as the main account for family and duo services).

How to share the Offer: The Referrer must go in its profile page and/or in the settings on the Deezer application to receive a referral link to share with their Referee. The Referrer undertakes not to spam the Referee and to ensure that they consent to receiving the link.

Conditions of eligibility: The Referrer will receive the Offer for each new Referee (in the limit of 10 valid Referees) who has: (i) used the Referrer's link to benefit from the Offer within the Term, (ii) streamed at least once per month on its Deezer's account and (iii) paid its first month of the Deezer Service selected. The Referrer must hold an active subscription to the Deezer Services until the Referee converts to a paid subscription to benefit from the Offer.

When do the Referrer receive the Offer: The Offer will be deducted from the Referrer's after the Referee's first payment. For annual subscriptions to Deezer Services billing will be delayed by 3 months at the time of the next subscription payment. The processing time, before application of the Offer, may take up to 2 weeks.

- (2) 3 months of subscription to Deezer Services offered to the Referee who has subscribed to a subscription to Deezer Services** (subject to the conditions below).

Who can be Referee: The Referee is a person who has never benefited from a free trial or subscribed to any of the Deezer service (as the main account for family and duo services).

Condition of eligibility: The Referee will benefit, from the Offer by (i) using the link sent by the Referrer within the Term (ii) having an account and subscribing to one of the Deezer Service (iii) entering their banking information at the time of subscription to the Deezer Service and (iv) accepting [Deezer general terms and conditions](#).

The subscription chosen when the Referee signs up will then automatically renew at the normal rate.

Deezer reserves the right to withdraw the right, to benefit from the Offer from the Referrer and/or the Referee if (i) you do not meet all the conditions detailed above, (ii) if we believe that you have engaged in any fraud or material abuse of this Offer.

The Referrer and the Referee, by accepting these general terms and conditions of the Offer, agree to receive communications from Deezer in the context of the Offer only.
